ART Shipbuilding and Shipyard Inc. It is one of the active maintenance and repair shipyards of Tuzla Region and has a berthing capacity of 100 ships per year with its two floating docks of 230 m and 185 m. It also carries out new construction yacht and ship projecting activities.

In addition, changes made or proposed to be made on the infrastructure, equipment materials, shipyard activities or materials in the workplace provided by the shipyard or by others, changes made in the environmental management system, including temporary changes, and their effects on the shipyard, processes and activities, risk in all processes. and opportunity assessment, applicable legal obligations related to the application of necessary controls, business

It covers the design of areas, processes, facilities, machinery/equipment operating procedures and work organization and their adaptation to human capabilities.

The scope of environmental dimensions is water, air, soil, sea as receiving environments; As neighbors, it includes the fields of neighboring shipyards and organizations, suppliers, all kinds of floating vehicles operating in or entering the bay.

Within the scope of the ship repair department, surface preparation and painting activities are carried out in the pools, and both sides of the pool are effectively screened and barriers are drawn in order to prevent the spread of waste paint and grit to the environment during the blast painting processes. Waste grit is collected regularly and sent to cement factories as an alternative raw material. Empty paint cans and all dyed and thinner waste generated during the paint process are collected separately at the source as hazardous waste and sent to licensed companies for disposal / recovery.

The wastes arising from navigation from ships are sent to the Authorized Waste Reception Facility through our shipyard, and the wastes generated as a result of the works carried out on the ships are sent to waste purchase companies licensed by the Ministry of Environment and Urbanization.

Our shipyard personnel regularly participate in the Cleanup Exercise of Spilled Oil and Derivatives, organized by GİSBİR-GİŞAŞ every six months for environmental emergencies, and are informed about action plans in possible emergencies.

While the environmental management system requirements of ART Ship Building and Shipyard Services Inc. are fully implemented, when there are improvement requests from the institutions in cooperation, these requests are also evaluated and necessary changes are made in the environmental management system.

The field of activity of ART Ship Building and Shipyard Services Inc. is defined as Ship, Yacht and Boat Design, Construction, Modernization, Maintenance, Repair and Equipment services.
